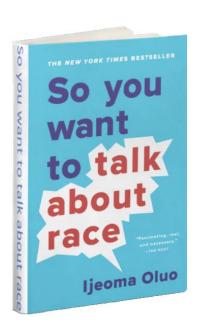


ANTI-RACISM LEADERSHIP BOOK CLUB
